

ORDINANCE # 2026-04

ORDINANCE PROVIDING FOR THE IMPROVEMENT OF VARIOUS STREETS AND LOCATION IN AND BY THE BOROUGH OF SUSSEX, IN THE COUNTY OF SUSSEX, NEW JERSEY, AS PART OF THE BOROUGH'S STREETScape PROJECT AND APPROPRIATING \$900,668.02 THEREFOR CONSTITUTING PROCEEDS OF A GRANT FROM THE NEW JERSEY DEPARTMENT OF TRANSPORTATION.

BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF SUSSEX, IN THE COUNTY OF SUSSEX, NEW JERSEY, AS FOLLOWS:

The improvement described in Section 2 of this ordinance is hereby authorized as a general improvement to be made or acquired by the Borough of Sussex, New Jersey, and there is hereby appropriated therefor the sum of \$900,668.02, from the proceeds of a grant received or expected to be received by the Borough from the New Jersey Department of Transportation as part of its Transportation Alternatives Program.

The improvement hereby authorized and the purpose for the financing of which the appropriation is made as provided in Section 1 of this ordinance is the improvement of various streets and locations in and by the Borough as part of the Borough's Streetscape Project, including the construction of pedestrian pathways and streetscape improvements and all lighting, pedestrian and bicycle pathways, sidewalks, curbing, crosswalks, lamp posts and signage, together with all milling, landscaping, curbing, drainage facilities, equipment, site work, work and materials necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved.

The capital budget or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

This ordinance shall take effect after publication after final passage as provided by law.
